1450. Village Voice

The Parish Councillors acknowledged the hard work and commitment of the volunteers David and Rhona Sharp who have been producing the Village Voice for many years.

- a) It was discussed and resolved that individual Parish Councillors should have more input into the Village Voice focusing on their particular area of interest for example the environment
- b) It was discussed and resolved and resolved a policy to allow businesses to advertise in the Village Voice, however as disclaimer was needed.
- c) It was agreed to set the rates for advertising in the Village Voice for the next Financial year to £90 to be reviewed annually at each precept meeting in December. It was agreed that advertisers need to pay up front for their adverts. To prevent advertisers being asked to pay two years together it was agreed the next invoice raised will be for the previous year and the

- next six months. Following this the invoices for adverts will be annually in advance of the advertising.
- d) It was agreed to attempt to cover the cost of the Village Voice through advertising.
- e) It was discussed and resolved and resolved even though the current local printer is above the market average price for the work the good working relationship they have will the volunteers who produce the magazine is important. It will be periodically reviewed

1452. Speeding Hollins Lane

The Parish Council discussed a residents' serious concern regards to the on road parking on Hollins Lane. Prior to the series of developments, traffic and speed has always been an issue. Since the developments of the houses, this has increase on a drastic scale.

Cllr. Tresilian has reported the parking issue to the Police. She will provide the Clerk with details of the vehicle registrations of the black Kia and the white car growing grass in it, to enable the Clerk to follow it up on behalf of the Parish Council.

The Clerk will write to Cllr's Leech and Salter to ask for their assistance with the speeding issues on Hollins's Lane.
