1545. Update the Standing Orders for Forton Parish Council

It was agreed that the Parish Council adopt an additional Standing Order which will allow the Parish Council to enter inti Legal Agreements: this will be Standing Order number 11.

The Parish Council thanked Cllr Young for the enormous amount of effort and time he has taken to organise the Section 106 agreement with Solicitor Carmel White at Wyre.

1546. S106 Deed Covenant for the new playground at the Village Hall.

Chairman Cllr. Huddart and Vice Chairman Cllr. Young signed it in the meeting. Cllr's Mcloughlin. Farebrother and the Parish Clerk witnessed it.

1547. Handover timetable for the new Parish Clerk.

It was resolved the Chairman would ring the Clerk to arrange dates once the new Clerk has been appointed.

It was agreed Forton Parish Council would take full ownership of the printer and return £89.52 to Kirkland Parish Council. There is limited stationery left and it was agreed the new Clerk would purchase new stationery on behalf of the Parish Council.

The Clerks remaining one weeks leave will be taken at the end of August.

1548. Banking Mandate

It was resolved to add the new Clerk (-----) to the banking mandate and to remove old Clerk. It was confirmed that Parish Councillors Huddart, Young and McLoughlin would remain on the mandate.

1549. Laurus Homes grant.

Following consultation with the Scout, Cub and Beaver leaders, and a list of primarily camping and ancillary equipment was produced, together with some maintenance and repair items for the Scout Hut. A list of items totaling £9,894 was finalised. A request has been made to Laurus homes for a grant of £9,984.

1550. Lengthsman.

It was resolved to defer to the September meeting when Cllr. Tresilan will outline her plans for appointing a Lengthsman with a list of duties and expectations of the role.

1551. Footpaths and progress with danger signs for the A6

It was discussed and agreed the Parish Council would fund up to £400 for safety improvements, where the public right of way crossing the Channing's land meets the A6. The Parish Council will apply for a grant from Lancashire County Council to upkeep the public rights of ways.

The Parish Council had previously asked Lancashire County Council for a metal barrier similar to the one across the A6. This was not allowed due to the width of the footpath on that side of the A6
