Minutes of the Forton Parish Council Meeting held At Forton Village Hall on Monday 7th June 2021 at 7.00pm

1363. APOLOGIES

1364. NOTIFICATION OF INTERESTS

Councillors were asked to disclose any pecuniary and nonpecuniary interests on matters to be considered at this meeting. None were raised.

1365. MINUTES OF THE LAST MEETING

Resolved: The update of the Parish Council meeting, held on 10th May 2021, was agreed.

1366. PUBLIC PARTICIPATION

The meeting was adjourned.

A resident raised concerns about speeding on Cockerham Rd and the proposed development of the barns into holiday lets.

Two candidates for the vacant Parish Councillor positions attended the meeting to observe. The Chairman confirmed that the Parish Council would interview potential candidates based on their responses to the questions detailed in the advert after the closing date 23rd June 2021

Cllr Leech sent information that Wyre Borough Council was now meeting in person. The Little Theatre was being used as a vaccination centre. The Fleetwood Marina Haven and Fleetwood market have now reopened.

1367. PLANNING APPLICATIONS

Application Number: 21/00551/FUL

Proposal: The conversion of agricultural buildings to provide 5 residential units to be used for the purposes of holiday accommodation and demolition of single storey building **Location:** Centre Farm Cockerham Road Forton

Resolved: Object because the buildings are not derelict but in active use by the tenant farmer of 59 years with a herd of 80 cows. The buildings are essential to him and the proposed plans would put him out of business. The acoustic assessment did not consider the noise and disturbance to nearby residents by holiday makers. The lane is a popular narrow public footpath in regular use and there are no passing places. The exit onto Cockerham road is inadequate and unsafe for the additional traffic.

Proposal: Replacement domestic garage/outbuilding (resubmission of 21/00409/FUL) **Location:** Clevelands Lancaster New Road Forton Preston Lancashire PR3 1AE Resolved: Objection This proposed structure is in the countryside and clearly visible from the A6. It would represent an urbanization of the countryside, blocking rural views and reducing openness. The proposed building would be 1.5 times the size of the house and 3 times the size of the existing garage. No significant change from previous application just the word agricultural taken out and changed to hobby use

Application Number: 21/00625/FUL Proposal: Two storey rear extension Location: Holly Barn Winder Lane Forton Preston Lancashire PR3 0AX Resolved: there was no objection. The Clerk was asked to write to Wyre Borough Council Planning

Cllr Young provided a general update on Planning within Forton

1368. The Parish Council discussed Climate change in detail and thought they could make the following contributions:-

- Use meetings, social-media, and Village Voice, to acknowledge and promote initiatives and the positive impacts that they have.
- Members contributing to government consultations on Planning changes, and proposed changes to the Highway code to support active travel.
- Creating green space in the village by consulting with contractors and other stakeholders to formulate a plan to manage green spaces, verges and pathways to maximise carbon sequestration and promote biodiversity.
- Possibly considering allotment sites.
- Working to improve public transport by encouraging the use of public transport by lobbying Lancashire County Council for improved bus services to and from the parish.
- Identifying potential sites for tree planting, and bird and insect boxes.
- Re-wilding patches of land in the village and are working up proposals to improve diversity.
- Providing feedback on wider council strategies for transport, housing as well as specific feedback on planning applications.

- Supporting planning applications that provide carbon neutral new homes with for example additional insulation and solar panels.
- Providing more cycle parking.
- Improving safety. Slow vehicles down, maintain safe walking and cycling paths and keep road signage clear.
- Consulting with Highways for weight/size restrictions for heavy goods vehicles travelling through the parish.
- Encouraging plastic free, water refill and other carbon reduction initiatives and promote businesses that achieve these.

The Clerk and Cllr. Taylor will reply to Wyre Borough's consultation on climate change.
